Fee Pay is your online payment solution for fees, fines, taxes, licenses, and more.

With Fee Pay, your users can make a payment in four simple steps:

→ Search for fee

→ Review fee details

→ Make a payment

→ Print or email receipt

- Define your fee lookup parameters, such as last name, account number, or invoice number.
- Allow users to enter a payment amount or choose from a list of fees.

- Obtain user feedback about their experience with an optional online survey.
- Opt for the Fee Pay *Lite* version where no load file exchange is required.
